

Have you ever thought about fostering? Now is your chance! DCHS is looking for fosters for kittens, puppies, and medical/behavioral needs cats and dogs.



Fosters provide temporary, in-home care for animals until they are adopted into a "forever" home. Aside from regular daily care (i.e., feeding, exercise) the responsibilities include, but are not limited to: basic training (housetraining, walking on leash); behavior modification (to

correct problems such as jumping); socialization and temperament evaluation (to determine whether the dog is good with people and other animals); medical care (taking the animal to vet appointments, dispensing medication); taking the animal

to adoption events; and of course plenty of playtime and snuggles.
